Prospective applicants should possess the following attributes:

- A law degree, or nearly completed law degree;
- A high level of academic achievement (Honours or equivalent is desirable but not essential);
- Outstanding research and analytical skills;
- Excellent verbal, interpersonal and written communication skills; and
- Editorial skills are an advantage.

Successful applicants must be available to attend the Associates' Induction Programme from Tuesday 2 January 2018 to Monday 8 January 2018.
