This publication is a guide only. What you call a judicial officer outside court will depend on the occasion. For example, in public places it may be appropriate to call a judicial officer "Mr" or "Ms" *Surname*, so as not to identify them as a member of the judiciary. At professional/social events, some judicial officers may invite being called by another name. If in doubt, ask them.
